Anliegen des Textes

Das eewco-Simulationsprogramm lag für mich eine Größenordnung über meinen bisherigen Programmierungserfahrungen. Auch die Programmiersprache MySQL Stored Procedures, die Anwendung von SQL, die neuere Version von Python und der Umfang der Kommunikation der Programme untereinander waren Neuland. Entsprechend häufig gab es Fehlermeldungen. Bei einigen gestaltete sich die Fehlersuche recht knifflig. Diese möchte ich hier wiedergeben, um anderen Neueinsteigern die eine oder andere Stunde der Suche zu ersparen.

Workbench

Wenn ein Teil des Skripts markiert ist, wird nur dieser ausgeführt.

Ein Blitz führt den ganzen Skript aus, der andere nur die Anweisung, in der sich der Cursor befindet.

Das Anzeigen einer Textvariablen mit langem Inhalt, wird im Ausgabefenster nur abgekürzt wiedergegeben mit drei Punkten am Ende. Der gesamte Inhalt lässt sich sichtbar machen durch markieren und dann rechte Maustaste klicken. In dem erscheinenden Kontextmenü gibt es ganz oben den Eintrag „Value Viewer“.

MySQL

„strict mode“

Die Funktionsweise des strict modes hat sich mir leider nicht vollständig erschlossen. Der mode soll dazu führen, dass unklare Anweisungen auch in Fehlermeldungen münden und nicht nur durch Warnungen abgefangen werden. Guy Harrison empfiehlt daher den Gebrauch des strict modes in seinem Buch MySQL Stored Procedures. Ich habe mich dem angeschlossen. Allerdings hat der strict mode noch eine zweite Funktion: Er soll verhindern, dass unerfahrene MySQL-Nutzer Anweisungen schreiben, die unbedacht riesige Schreib- und Löschaktionen nach sich ziehen. Deshalb werden etwa UPDATE-Anweisungen nur ausgeführt, wenn sie mit einer WHERE-clause versehen sind, die sich auf eine Spalte mit Index bezieht. Für die Programmierung kann dies extrem hinderlich sein, weil die einfachsten UPDATE-Anweisungen dadurch zu Fehlermeldungen führen. Lösung ist nicht das Einfügen sinnfreier Schlüssel und WHERE-clauses, sondern die Anweisung: SET SQL_SAFE_UPDATES = 0;

In einem Fall gab es auch eine berechtigte Fehlermeldung: Bei Testläufen hatten sich mehrere Eintragungen derselben Art in einer Tabelle angesammelt, wobei nach Programmierlogik nur eine möglich gewesen wäre.

Prepared Statements

- Verwenden, um in Abfragen Variablen verwenden zu können.
- Funktionieren nur mit User Variables (@var).
- Auch innerhalb des Statements funktionieren nur User Variables. Wird eine deklarierte Variable verwendet, gibt es die Fehlermeldung „Variable XY not defined“.

User Variables (@var)

Vorsicht, die Debugging-Hinweise werden mit ihrer Verwendung sehr viel indirekter. Tippfehler führen nun dazu, dass das Programm neue Variablen einrichtet und nicht zur direkten Fehlermeldung. Um Tippfehler zu vermeiden, habe ich mir angewöhnt User-variables nur einmal zu tippen und dann per copy-past weiterzuverwenden.

Kommentare nicht erkannt?

Mir scheint, das MySQL Kommentare nicht immer sauber als solche erkennt. Insbesondere Kommentare die durch /* */ eingeschlossen sind.

SELECT [Null] INTO variable

Vorsicht: Der Wert der Variablen wird nicht überschrieben, wenn das Ergebnis des SELECTS NULL ist.

CONCAT('texttexttext', @var)
ergibt NULL wenn @var NULL ist.

IF ... THEN

END IF; nicht vergessen. Die auftauchende Fehlermeldung weist nicht explizit darauf hin. Die Fehlermeldung taucht auch entfernt auf: Wenn die IF-Abfrage ohne END IF in eine Schleife eingebaut wird, taucht die Fehlermeldung bei END LOOP auf.

enum

SELECT einer enum-Variable führt zu keiner Fehlermeldung, wenn die abgefragte Ausprägung nicht angelegt ist.

SELECT MAX(wert), und noch ebbes

Order by noch ebbes. Dann kann es passieren, dass MAX(wert) und noch ebbes aus unterschiedlichen Zeilen zusammengesetzt werden.

Python - MySQL

Unbound SELECT-Anweisung verstopft Übertragungskanal

Das ist der Fehler, nach dem ich am längsten gesucht habe. Ich habe von Python aus über pymysql eine Connection definiert, einen Cursor geöffnet und dann Daten aus einer bestimmten Tabelle gelesen. Bei den Simulationsläufen hat das auch die ersten beiden Simulationsmonate geklappt, im dritten wird nur NULL ausgegeben, dann klappt es wieder 2 Monate usw. Des Rätsels Lösung war: Jeden dritten Simulationsmonat ist das Programm an einer Stelle vorbeigekommen, an dem eine ungebundene SELECT-Anweisung stand. Diese SELECT-Anweisung hatte ich zum Debuggen eingerichtet und anschließend nicht deaktiviert.
